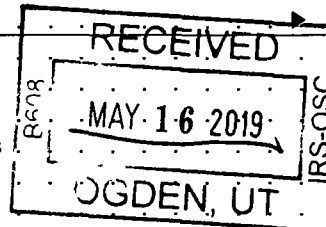

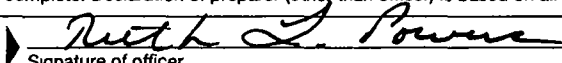

Grants made in 2018 totaled \$116955. The grants were all made to the Heather Chimoga Orphan Center in Zimbabwe. Grants are generally made via wire transfer to the bank account of HCOC in Zimbabwe. ZMP has significant influence over how the funds are distributed in Zimbabwe, but it does not have signing authority over the local bank account. Thus grants are not made directly to vendors, schools, workers etc.

Part I, Line 16

The "other" expenses in 2018 of \$7148 were for an annual bicycle event (a primary fund raiser).

Part II, Line 26

The amount on this line (\$12199) has been designated for a specific project but was not spent in 2018. In order to keep track of this commitment - while still using cash accounting - we account for it as a liability and it will be spent as promised in 2019.
