THE US FUND MAINTAINS A WEB SITE THAT ATTRACTS INDIVIDUAL DONORS, AND IS LISTED ON EMPLOYEE MATCHING DONATION PROGRAMS FOR SEVERAL LARGE CORPORATIONS INCLUDING BANK OF AMERICA, CHEVRON, AND APPLE. THE US FUND ALSO PARTICIPATES IN FUNDRAISING PROGRAMS SUCH AS BENEVITY. IN ADDITION, THE US FUND HAS A CLOSE PARTNERSHIP WITH (PRODUCT)RED (WWW.RED.ORG) ("RED"), A PROGRAM OF THE US-BASED CHARITY ONE CAMPAIGN (WWW.ONE.ORG), THAT SEEKS TO RAISE FUNDS THROUGH INDIVIDUAL AND CORPORATE DONORS ON OUR BEHALF. THIS IS ACCOMPLISHED THROUGH AN AGREEMENT THAT ALLOWS RED TO SOLICIT AND COLLECT FUNDS ON OUR BEHALF. THESE RANGE FROM MASSIVE INDIVIDUAL GIVING CAMPAIGNS, COMMERCIAL CO-VENTURES, AND CORPORATE DONATIONS. THIS WORK IS ONGOING AND HAS BROAD REACH ACROSS THE UNITED STATES AS WELL AS INTERNATIONALLY. TOGETHER, THESE DIFFERENT FUNDRAISING CHANNELS HAVE RAISED MILLIONS OF DOLLARS FROM HUNDREDS OF INDIVIDUALS AND BUSINESSES, OBTAINING BROAD PUBLIC SUPPORT THAT ALLOWS US TO CONTRIBUTE TO THE WORK OF THE GLOBAL FUND.

HE ALSO SERVES AS A SENIOR ADVISOR TO THE CENTER FOR STRATEGIC AND INTERNATIONAL STUDIES IN WASHINGTON, DC - CHRIS COLLINS, THE US FUND'S TREASURER, IS THE PRESIDENT OF FRIENDS OF THE GLOBAL FIGHT, WHICH ADVOCATES ON BEHALF OF THE GLOBAL FUND IN WASHINGTON, DC, AND IS A LONGSTANDING LEADER IN HIV ADVOCACY IN THE UNITED STATES - RICHARD PARNELL MANAGES A PRIVATE ADVISORY SERVICE FOR PHILANTHROPISTS AND WAS FORMERLY THE CHIEF FINANCIAL OFFICER FOR THE UNITED NATIONS FOUNDATION - NATASHA BILIMORIA, FORMER PRESIDENT OF FRIENDS OF THE GLOBAL FIGHT AND A DEDICATED ADVOCATE FOR GLOBAL HEALTH AND DEVELOPMENT ISSUES, CURRENTLY SERVING AS THE DIRECTOR OF U.S. STRATEGY FOR GAVI. THESE INITIATIVES ATTRACT A WIDE VARIETY OF PARTICIPANTS THAT ALL COME TOGETHER TO SUPPORT THE US FUND AND ITS MISSION.
