THE GOAL WITH THIS PROGRAM IS TO AVOID HAVING TO FIND A BUILDER CAPTAIN, WHICH CAN DELAY THE TURNOVER, HAVE A VERY SPECIFIC SCOPE OF ONLY FLOORING AND PAINT, WHICH NOT ONLY SAVES THE SHELTER ORGANIZATION MONEY AT THE ONSET BUT ALSO SAVES THEM MONEY OVER TIME WHEN THEY DON'T HAVE TO RENOVATE THE FLOORING AFTER FUTURE MOVE-OUTS, AND TO HIRE AND PAY TRADE PARTNERS FAIRLY FOR QUICK TURNAROUND, WHICH ULTIMATELY HELPS FACILITATE A NEW FAMILY THE OPPORTUNITY TO FIND STABILITY AND SAFETY IN A SHORT AMOUNT OF TIME. THIS PROGRAM WILL BE FUNDED BY HOMEAID.
