Chevra provides humanitarian aid to Jewish people, many of whom are elderly and Holocaust survivors, in the former Soviet Union and in Israel, by operating soup kitchens and distributing food parcels, warm clothing, medicine and other items to those who are in need.

We partnered with our sister organization in Israel to provide humanitarian aid to new immigrants and impoverished Jews in Israel. We have very little overhead to administer this service so most of the designated funds are sent to provide these needed services. In Israel, we are helping not only new immigrants but also the elderly, Holocaust survivors, single mothers and the disabled. The mismatch between income and expenses is a matter of end-of-year timing between receiving donations and disbursing the funds.

4b (Code _____) (Expenses \$ 45,594 including grants of \$ 45,564) (Revenue \$ 14,921)
We support soup kitchens in a number of cities in Ukraine which feed a large number of people each month in addition to our regular humanitarian aid distributed in that country. Ukraine has been very hard hit by conflict in recent years, displacing many people from their homes. The grants we made to Ukraine were supplemented by unrestricted donations over and above those we received that were specifically designated for our Ukraine ministry.

We support our full range of humanitarian services in Poland, funded through unrestricted donations as well as donations we receive specifically designated for use in Poland.
