The organization's mission is to provide health care education and services globally, with emphasis on Dr. Sima Yaftali's native country of Afghanistan. The organization manages a medical clinic in Kabul, Afghanistan. The organization also produces and broadcasts educational health care shows globally via Ariana Afghanistan Satellite Television.

Office Visit - the organization manages a medical clinic in Kabul, Afghanistan, and treats patients for very low cost or even for free, depending on the patient's economic situation. The clinic charges low office visit fees to prevent misabuse of the organization's services. Expenses include the salary for 14 employees (medical doctors, nurses, staff, etc) as well as operating costs of the clinic. The revenues represent office visit fees. The clinic treated on average more than 900 patients per month in 2018.

**4b** (Code: ) (Expenses \$ 55,820 including grants of \$ 0) (Revenue \$ 37,585)  
Pharmacy - The clinic sells medical drugs to patients for very low cost or provides them for free, depending on the patient's economic situation. Expenses include the cost of purchasing the medical drugs as well as the cost of salary for 2 pharmacists. Revenues represent the proceeds from selling medical drugs. The clinic's pharmacy department sold or provided medical drugs on average to more than 700 patients per month in 2018.

Educational Health Care Shows - the organization produces educational health care shows and broadcasts them globally over Ariana Afghanistan Satellite Television. Dr. Sima Yaftali pays for the expense of producing and broadcasting the shows from her own personal finances. The educational health care shows do not directly produce any revenue for the organization. Many of the educational health care shows are available to the public at no cost on the organization's website: www.health-for-everyone.org.
