ABOHLF is hosting the first-of-its-kind online, animated patient education program at www.youandlungcancer.com, soon to be available in Spanish. The beauty of this program is its ability to overcome barriers of education and medical illiteracy to educate lung cancer patients and their family members where they're at. ABOHLF's Ambassador Program provides transportation, companionship visits and support groups for patients, as well as an annual Patient Summit with high level education directed at patients and caregivers living with lung cancer. ABOHLF is also hosting a local, quarterly grief group for families who have lost a loved one to lung cancer.
