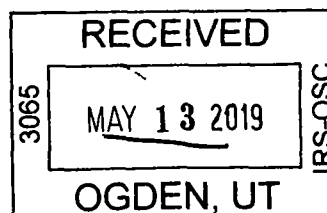



In 2018, there were 807 donations for an average amount of \$10 from the general public. More than 10% of donations by dollar amount were from the general public in 2018. The foundation received large lump-sum donations from a credit union that represents more than 100,000+ members of the general public in 2016 (\$100,000) and 2018 (\$62,389). As these large lump-sum donations were made by a financial cooperative wholly-owned by its members, these donations are appropriately considered as separate donations from each member; thus the 33 3% public charity test is satisfied.
