The Hospital Elder Life Program (HELP) is designed to promote a safer and more enjoyable hospital stay for older adults. By combining the skills and resources of hospital staff and volunteers, the program helps to minimize delirium. HELP interventions are focused on safety, thinking exercises, pre-mobilization activities, including bed and chair exercises, nutrition and hydration assistance, sleep promotion, and breathing exercises to prevent respiratory complications, and feet pumps to prevent blood clots. In 2018, the Elder Life Specialists and HELP Volunteers provided 5,438 patient visits.

Emmetts Place is a space for families to be together during a stay in Miami Valley Hospital's Neonatal Intensive Care Unit. Located in the Berry Womens Center, with operational support for staffing funded by donor contributions, Emmetts Place provides a safe and comforting area at Miami Valley Hospital for families to gather, relax and have a sense of normalcy together. The Ronald McDonald Family Room, located inside Emmetts Place, is a quiet and restful space that serves perinatal mothers and the families of NICU babies, providing light meals, snacks and laundry facilities. 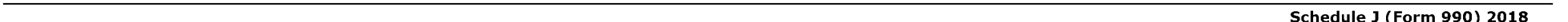
