THIS STATEMENT UNDERSCORES THE FOUNDATION'S ROOTS IN MIAMI COUNTY, HOWEVER, THE BOARD MAY IN ITS DISCRETION AUTHORIZE GRANTS TO CHARITABLE ORGANIZATIONS OUTSIDE THE MIAMI COUNTY AND CENTRAL OHIO REGIONS. THE FOUNDATION WILL HONOR PAUL DUKES' CONCERN FOR CHILDREN, FAMILIES, AND THE MOST NEEDY MEMBERS OF SOCIETY.
