Incentives are only available to non-residential customers with annual electric usages of more than 250,000 kWh. Funds for the program are limited and subject to availability. Funds are monitored using the following requirements: 1. Applicant must submit a pre-approval application and receive pre-approval from the City of Westerville before being eligible to receive an incentive. 2. Projects must involve a facility improvement that results in a permanent reduction in electrical energy usage (kWh). (City of Westerville reserves the right to develop cost effectiveness tests to determine if project qualifies for an incentive.) 3. Projects must be installed on the City of Westerville electric account listed on the application. 4. Equipment must be purchased, installed and operating (or capable of operating in the case of seasonal uses) prior to submitting a final incentive application. 5. The final application must be submitted within 60 days of project completion. Project documentation, such as copies of dated and paid invoices for the purchase and installation of the energy efficiency measures, along with product technical specification sheets, must be included with the final application. (The City of Westerville reserves the right to request additional supporting documentation as necessary to confirm eligibility and verify savings.) 6. By applying, the customer grants the City of Westerville the right to perform pre- and post-installation inspections. 7. The City of Westerville reserves the right to perform monitoring and inspection of the energy efficiency projects for a three year period following completion of the installation in order to determine the actual demand reduction and energy savings.
