Sustainable Agriculture: Continued to operate the Chesterhill Produce Auction, which grossed \$308,597 in sales and hosted 152 growers, who in turn sold to 71 businesses, restaurants, and schools, and 1,059 individual buyers. Increased from 5 to 10 Country Fresh Stops to provide fresh produce to food desert communities. Expanded the Farm to School project, purchasing 10,048 pounds of fresh local produce to process and distribute to 5,154 students in 18 area schools. Zero Waste: 83 businesses and organizations participated in sustainability events or pledged to reduce waste and increase recycling. OhioHealth O'Bleness Memorial Hospital, with the support of our team, created a sustainability plan which reduced their dumpster waste by 50% (saving them \$10,000), will reduce electricity and water usage, and increase the use of fresh foods in their food service. Our social enterprise Zero Waste Event Productions spun off to create a business, employing 3 people and diverted 60,448 pounds of waste from the landfill by "zero wasting" 23 festivals in 3 states. Continued our partnership with the Athens Hocking Solid Waste District to increase recycling rates through the completion of 60% of the action steps in the Zero Waste Action Plan. Residential/commercial recycling rates in the district rose to 36.62% in 2018, more than triple the rate when the program started in
