IN 2018 THE FOUNDATION FACILITATED A TEMPORARY ASSISTANCE FOR NEEDY FAMILIES (TANF) GRANT BETWEEN THE DEPARTMENT OF JOBS AND FAMILY SERVICES AND THE TWO THIRD PARTY SERVICE PROVIDERS. THE FOUNDATION OBTAINS REIMBURSEMENT SUBMISSION FROM THE PASS-THROUGH THIRD PARTY SERVICE PROVIDERS AND SUBSEQUENTLY SUBMITS REIMBURSEMENT REQUESTS TO THE DEPARTMENT OF JOBS AND SERVICES. THE FUNDS ARE PASSED THROUGH TO THE THIRD-PARTY SERVICE PROVIDERS. REVENUE AND EXPENSES RELATED TO THESE TRANSACTIONS ARE SHOWN AS OTHER INCOME AND EXPENSE ON THE STATEMENT OF ACTIVITIES. IN 2018, THE FOUNDATION FACILITATED THE HEALTHY BEGINNINGS AT HOME (HBAH) AND HPEM PROGRAMS. HBAH SERVES LOW INCOME PREGNANT WOMEN WHO ARE NEAR HOMELESS AND HOMELESS WOMEN FIND STABLE HOUSING DURING PREGNANCY AND THROUGH THE INFANT'S FIRST YEAR OF LIFE. HEALTHY BEGINNINGS AT HOME IS IMPLEMENTED THROUGH A PARTNERSHIP WITH HFF, COLUMBUS METROPOLITAN HOUSING AUTHORITY (CMHA), STEPONE FOR A HEALTHY PREGNANCY, AND CARESOURCE TO PROVIDE RENTAL SUBSIDIES AND MEDICAL SERVICES TO MEDICAID-ELIGIBLE PREGNANT WOMEN WHO ARE HOMELESS OR NEAR HOMELESS. THE RESULTS OF THE BIRTH OUTCOMES WILL THEN BE COMPARED TO A SIMILAR GROUP OF PREGNANT WOMEN WHO ARE RECEIVING USUAL PRENATAL HEALTHCARE SERVICES. HPEM SERVES LOW INCOME PREGNANT WOMEN AND THEIR FAMILIES AT IMMINENT RISK OF BECOMING LITERALLY HOMELESS, HELPING THEM REMAIN HOUSED TO IMPROVE THE HEALTH OUTCOMES OF THEIR NEWBORN BABIES.
