The solar and wind systems are small and are used for educational teaching tools and they do not save very much on the school's electricity bills. They are classroom teaching tools that just happen to also generate a small amount of solar electricity. The average cost of such a solar system is less than \$8,000. The wind systems are partial grants. The average cost of a wind system is \$45,000. This program ended up providing over \$150,000 to k-12 schools.

Conduct teacher training workshops for teachers Throughout Illinois These trainings are free to teacher at our solar and wind schools and materials are available for downloading free of charge for classroom use We pay for substitute teachers so that schools do not have to incur any costs in allowing its teachers to attend the trainings Evaluations for the workshops are very high and we almost always are at full capacity We also provide each school with classroom kits again free of charge If needed we pay for hotels and mileage and misc snacks and breakfast and lunch Our goal is to assist low income schools get access to classroom materials that will hopefully help their students find work in the renewable energy field In 2016, 52% of all new jobs created in the US were in the renewable energy field But many schools have teachers and students who have never touched a solar panel Our program helps them gain access to materials and training that will hopefully lead to more jobs being created in rural and low income areas In 2018, we started an arts training center for low income and minorities in Columbus, Ohio that will help with literacy
