Research Costs - In 2018 The LAM Foundation and the Rare Lung Disease Consortium hosted in Cincinnati the 2018 International RLDC Conference and LAMposium. We had 222 researchers and medical professionals in attendance at the conference from the United States and 22 international countries. These researchers and medical professionals spent 2.5 days in meetings to further research LAM and discuss care for patients living with the disease. The Foundation hosted the annual grant study section in Phoenix, Arizona, during these 1.5 days the committee reviews and approves the grant distributions for the year. In 2018, the Foundation expended \$564,033 in grants to further the research for a cure. The Foundation also distributed \$14,765 in funds to assist patients with their travel for MILD research. We also distributed \$9,315 to patients to assist with their first time travel to the National Institute of Health.

Form 990, Part III, Line 4b:

Patient Services - In 2018, The LAM Foundation and the Rare Lung Disease Consortium hosted in Cincinnati the 2018 International RLDC Conference and LAMposium. We had 117 LAM patients and 74 family and friends of LAM patients in attendance. The Foundation sponsored 24 LAM Regional Educational Meetings in partnership with 17 LAM clinics, educating more than 400 attendees across the country. The Foundation also produced "Journeys", a publication which provides updates on clinical research and how to live with LAM. The Foundation registered 168 new patients in 2018.

Clinical - The LAM Foundation supported its 63-member global LAM Clinic and Research Network via two hosted webinars, and an in-person SAB and Clinic Director meeting at the American Thoracic Society Annual Meeting in San Diego, CA (58 attendees) in May. The Foundation supported LAM Clinic site participation in the MIDAS trial via coordination of the clinical site agreements and payments. ATS/ERS LAM Guidelines were presented at four professional conferences and the LAM and RLDC virtual CME programs were launched.
