<p>Hand of Hope is an organization dedicated to making a difference in the lives of people in southern Ethiopia and Kenya through orphan care, aid to the poor and evangelism. During 2018 we provided support to 40 orphans in southern Ethiopia as well as 22 orphans and 25 impoverished children in northern Kenya by providing financial assistance for their education, food and clothing. Hand of Hope partnered with local churches in Ethiopia to provide pastor training and sent two teams from the USA to Ethiopia and Kenya to conduct vacation bible school for children, a youth conference, as well as meet with orphans sponsored and supported by Hand of Hope. In 2018, Hand of Hope also provided funds to a school in Golole, Kenya with much needed textbooks.
