New research from the lab of Dr. Catherine Hedrick showed how a diet

high in fat and cholesterol depletes the ranks of artery-protecting

immune cells, turning them into promoters of inflammation, which

lead to heart attack or stroke. Hedrick's lab is investigating the roles that immune cells play in this process and how the function of different immune cells can change as atherosclerosis progresses. The team has also found that high density lipoproteins (HDL)-more commonly known as "good cholesterol"-counteract this process, helping the protective immune cells maintain their identity and keep arteries clear.

In their latest study, Dr. Mitchell Kronenberg and his team identified a subset of T cells, whose frequency serves as early childhood immune signature that predicts the risk of developing asthma later on. Asthma is a chronic inflammatory disease driven by the interplay of genetics, environmental factors and a diverse cast of immune cells. Consistent with the "hygiene hypothesis," which holds that increased microbial exposure in the first years of life is protective for asthma, the team's findings also indicate that the presence of house dust components that stimulate the innate immune system decreases asthma risk. The study, was part of the larger Urban Environment and Childhood Asthma (URECA) study funded by the National Institutes of Health. Initiated in 2005, the study follows 560 families from four disadvantaged urban areas who are at high risk for asthma to uncover potential risk factors that contribute to increased asthma rate in children growing up in impoverished neighborhoods.

A new paper published by Dr. Klaus Ley reports the successful vaccination of atherosclerotic mice with a small chunk of protein snipped out of "bad cholesterol." Vaccination reduced plaque levels in test mice, and other experiments with human blood samples identified

the class of T cells likely responsible for positive outcomes. The paper suggests that a comparable strategy could form the basis of a human vaccine. In the disease atherosclerosis, cholesterol-containing plaques form in vessel walls, causing arteries to narrow and greatly increasing the risk of heart attack and stroke. Currently, atherosclerosis is the number 1 killer worldwide, just ahead of cancer. Recent use of statin anti-cholesterol drugs has reduced cardiovascular events caused by atherosclerosis by 35%, but millions of individuals remain at risk. Hence, a desirable addition or alternative would be intervention to prevent plaque formation altogether.

The current whooping cough vaccine was universally adopted in the US in 1996 to replace the original vaccine based on killed Bordetella pertussis because of a stronger safety profile. The new formulation was found to be effective in preventing whooping cough during vulnerable stages in the lifespan, but the kind of pertussis vaccine used to prime the immune system leaves a lasting impression. Dr. Alessandro Sette and his team reported that individuals who had been inoculated with the newer vaccine as part of their initial series of shots, mount a weaker recall response when receiving booster shots later on. Specifically, the study found that the new vaccine fell short of generating a robust T cells response, which provides the long-term memory that allows the immune system to mount a rapid response if exposed to the pathogen. Unraveling the differences between the two vaccines is key to understanding of how to better prevent whooping cough and may also provide important lessons on vaccine efficacy in general, potentially applicable to other vaccines.

Neutrophils-short-lived, highly mobile and versatile-outnumber all other immune cells circulating through the blood stream. Yet, despite the cells' abundance, the progenitor cell that only gives rise to neutrophils had eluded all efforts to track it down. Now, Dr. Catherine Hedrick's lab identified a progenitor of neutrophils in the bone marrow of mice and humans and tied it to cancer-promoting activities. Their study found that neutrophil progenitors promote tumor growth and that the frequency of the usually rare cell increases dramatically in the blood of human melanoma patients. The findings could assist in the detection of cancers by serving as an early warning sign and drive new therapeutic and pharmaceutical approaches for the treatment of neutropenia, chronic inflammation and cancer.
