In the U.S., 1.7 million youth experience homelessness every year. Fifty thousand youth sleep on the streets for six months or more each year. Thirteen youth die on the streets each day. StandUp For Kids' addresses the need through its four (4) core services; Street Outreach, Housing Support, Outreach/Drop-In Centers and Mentoring Programs. These services provide youth with basic necessities; vital information regarding available resources to meet their needs; housing; advocacy, other resources to assist in alleviating the problem of youth homelessness and prepare them for self-sufficiency. In 2018, StandUp For Kids provided over 53,000 instances of support nationwide.
