In perpetuity sponsorship of annual Tibetan Buddhist Nyingma World Peace Ceremonies at Bodhgaya INDIA, including daily offerings to monastic participants; ceremony offerings of butter lamps, candles, tsog (food), flowers; and daily food offerings to the local poor. Head Lama of TNMC Yeshe De Project religious texts, books and art are transported to Bodhgaya where they are freely distributed to monastic and lay practitioners.

This grant was for the ceremony in January 2019. Funds were wired to Head Lama of TNMC in August of 2018 to make arrangements ahead of the ceremony. All of these expenses were under pre-approved and reconciled budget control by Head Lama of TNMC budget committee. 7000 monks, nuns and high lamas attended the 10 day ceremony. Daily offerings included flowers, food for the local poor; tea rice and biscuits for the assembly and lay people were also offered. Light offerings from 100,000 butterlamps were made everyday. Sacred text readings were sponsored at local monasteries. Yeshe De Publication books were freely distributed to the monastics and lay people during the ceremony.

Funds were sent to Head Lama of TNMC in November of 2018 to provide in advance for the annual ceremonies in Jan of 2020 & 2021. We expect the activities in these next two years to be consistent with the activities of the last 30 years. The number of attendees and offerings are all controlled through a budget process by Head Lama of TNMC; that process links with the religious communities who attend the yearly ceremonies. The ceremonies are calandared in the Bodhgaya Stupa management committee event schedule for the same days in the lunar calandar annually.

The Head Lama of the Tibetan Nyingma Meditation Center (TNMC) is the supported organization of the Bodhgaya Religious Trust. The assets of the Bodhgaya Trust are all in a Vanguard account. The Vanguard account manager met with members of the Board several times during the year to discuss the investment performance, policies and asset allocations of the account. These members include the Head Lama and President of TNMC who is also President of the Board of the Bodhgaya Trust, as well as the Treasurer and other members of the Board. In addition, monthly statements and quarterly performance reports are sent to the Treasurer and the office of the Head Lama of TNMC. Head Lama meets with members of the Board and yearly establishes a detailed budget for the annual ceremony. At the end of the ceremony, a report is made reconciling the budgeted and actual expenses for that year's ceremony. Any carryover funds and leftover funds are accounted for and deposited with the ceremony committee of monasteries in India for use the following year. Head Lama oversees these budgets and reports and shares them with the Bodhgaya Trust Board. Signatories on the Vanguard account are all members of the Bodhgaya Trust board.
