Program 2 helps the victims of a very huge environment disaster along 400 miles of sea shores of Viet Nam created by Formosa Steel Complex (a Chinese steel Company) in 2016 which kill millions of fishes, spread toxic chemical waste along the coast. This program provide small financial aids to the victims and help build new production of medical mushroom for fishermen displaced by the disaster.

Program 3 support 5,000 to 6,000 disabled veterans of the Republic of Viet Nam. Grants were transmitted to the Redemptorist Priests who gather them in the church yard area of the Redemptorist Religious Order on Ky Dong Street, Saigon by 1,000 per week end during December before Christmas. These RoVN disabled veterans are provided healthcare services, meetings, social activities and money gifts.
