Provided 8 water projects within the states of Gujarat and Maharashtra. It is estimated that these projects benefited 4,000 rural men,
women and children. These were taken up by our indigenous partner Ashirwad Kendra Trust (ASK). In addition to the water projects,
financial support was also provided for Lydia's Girls Hostel which is operated by ASK. This hostel provides food, shelter and a way
for the 22 girls to receive an education at the college or university level.

4b (Code:) (Expenses \$ 73,260 including grants of \$ 38,177) (Revenue \$ 832)

Provided 14 water projects within the state of Andhra Pradesh with our indigenous partner, Society for Helpless and Economically
Backward Areas (SHEBA). It is estimated that these projects benefited 10,000 rural men, women and children. In addition to the
water projects, financial assistance was provided for a monthly program benefiting a leper community of 40 families, along with an
outreach program for a nomad community of 50 families. SHEBA also operates an orphanage of 240 orphan and semi-orphan
children and financial assistance was granted to support the teaching staff and to purchase clothes and gifts at Christmas.
