

**ILASS-Americas primary program service is to host an annual technical conference. Every nine years the organization hosts an international conference. In 2018 ILASS-Americas hosted an international conference that was held in Chicago IL, July 22-26, 2018.**

**The conference (ICLASS) was attended by approximately 450 people and 180 technical papers were presented.**

**Also reported in this tax filing are the majority of the financials associated with the 2017 annual technical conference. The accounts for the 2017 meeting were not closed, and transfers did not occur, until early 2018; thus they are included in this filing.**

**The 2017 annual conference was held in Atlanta, GA May 15-18, 2017. The conference (ILASS) was attended by approximately 135 people and 90 technical papers were presented.**

**2017 ILASS Meeting (partial) Expenses: \$66,673 Revenue: \$112,791**

**Additionally, the travel expenses of three keynote speakers were reimbursed.**

**Student travel awards (\$13,703) + Keynote speaker awards (\$8,878) = \$22,581**

In 2018 ILASS-Americas provided travel stipends to 14 students to attend the international conference in Chicago, IL, July 22-26, 2018. In all cases the travel awards/grants did not exceed \$1000 and the actual payout was limited to documented travel expenses (total payout was \$13,703). Additionally, the travel expenses of three keynote speakers were reimbursed. One speaker was domestic (reported above: \$2,374), while the other two were foreign (see schedule F). In all cases, reimbursement was limited to documented travel expenses.
