After the initial verification takes place a Program Officer/Grant Manager is assigned to each proposal. Additionally, site visits are conducted with representatives from the organization and a narrative summary is completed for the Distribution/Grant Committee. All proposals are then carefully reviewed by the staff and Distribution/Grant Committee to identify those applications that best serve the Foundation's mission and to analyze proposed budgets to fulfill obligations as stewards of Foundation's funds. After the selection process is complete, the Distribution Committee makes its recommendations to the full Board of Directors at its next meeting. Once a grant is awarded, grantees are monitored through site visits to insure proper use of funds. Submission of periodic reports and budget information is required and reviewed for consistency and adherence to program goals and objectives. When the grant period has ended, closed grant/final evaluation reports are completed and reviewed by the Program Officer/Grant Manager for compliance with the grant agreement and used as an internal document to inform future funding. Grant files are archived electronically for future reference.

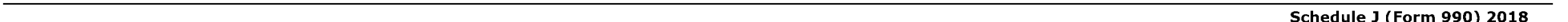
