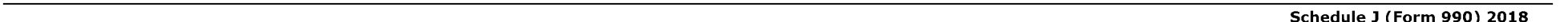

Conflicts of interest discovered once a transaction is in process will be addressed by the Board as soon as possible, and the interested person may be subject to discipline, including termination, for failure to disclose the conflict in a timely manner.

The Committee engaged Quatt Associates (Quatt) and Price Waterhouse Coopers (PWC). The recommendations and feedback were taken under advisement by the Committee. The market analysis process involved, a review of the executive's current compensation and responsibilities, determination of a specific market place of comparative organizations, market analysis of the comparable peer group and finally, Quatt and PWC submitted specific recommendations for both base and variable pay adjustment for the CEO position. In addition, the Board conducted the annual performance assessment for the CEO. That process involved the following: The CEO provided an outline of his accomplishments for the prior year to the Compensation Committee. He recommended a list of staff members and others to participate in the confidential survey of his performance, conducted by the Compensation Committee. The Committee distributed the same survey to all Board of Trustee members. The survey results were compiled by the Chair of the Board, in confidence. The Chair shared a synopsis of the feedback with the members of the Compensation Committee. (The Compensation Committee is comprised of either Officers of the Board of Trustees and/or past Chairs of the Board of Trustees). During Fiscal Year 2017 the Compensation Committee (using information gathered from the independent consultants (previous years) and committee members) asked the CFO to prepare a compensation market analysis. This process involved the CFO assembling a collection of data from a specific marketplace of comparative organizations identified by the Compensation Committee and President/CEO. The Committee then determined both the base and variable pay adjustments for the President/CEO position. During 2018 the Compensation Committee reviewed the past years compensation studies and materials and gave the President an increase that was the same as all Museum staff members. Subsequently, the Compensation Committee made a compensation recommendation which was shared with the Executive Committee of the Board of Trustees for approval. The Executive Committee then approved the recommendation of the Compensation Committee. This occurred in March of 2015, March of 2016, April of 2017 and April of 2018 (The new rate was retroactive to January 1, 2015, 2016, 2017 and 2018). The decision was reported to the full Board of Trustees, in private Executive session, this occurred during the May, 2015, May, 2016, and May, 2017, May 2018 Board Meetings. The Compensation Committee with the approval of the Executive Committee executed a 5-year employment agreement on December 2, 2014, which will expire on December 31, 2019.
