Form 990 is reviewed and approved by the Finance Committee, then electronically submitted to the Board of Directors sufficient prior to their next meeting. At the next meeting, a short presentation of the Form 990 is conducted with discussion prior to full Board of Director approval.

**Form 990, Part VI, Line 12c - Explanation of Monitoring and Enforcement of Conflicts**

At the first board meeting following the Annual Meeting of Members (typically February) all Board Members are required to sign a Conflict of Interest Policy acknowledgement and also disclose in writing any known or potential conflicts.

**Form 990, Part VI, Line 15b - Compensation Review & Approval Process - Officers & Key Employees**

The personnel committee made up of external Human Resources expertise developed, approved and maintains with regular updates a salary administration program based on a national and local compensation study. The program includes a Salary Structure for the organization and includes Officers and Key Employees. Officer salary is reviewed for compliance within the program annually.

**Form 990, Part VI, Line 19 - Other Organization Documents Publicly Available**

IRS Form 990, Independent Financial Audit and Conflict of Interest Policy is available to the public on the organization web-site at all times.
