Financial assistance to the needy. Throughout the year we provide food for the homeless and emergency food for the needy. We also provide funds to help with evictions, utilities, terminations, medical bills, travel expenses, funeral expenses, and tuition. We also provide cleaning supplies, toiletries and paper supplies to a senior citizens apartment building. In the winter, we provide blankets, gloves and hats. We serve 500 people per month.

This program operates year round.

4b (Code:) (Expenses \$ 48,000 including grants of \$ 55,000) (Revenue \$)

This program provides financial assistance to refugee families. The assistance included paying rent, utilities, and providing food, clothing, counseling and employment referrals. Translators were also provided. We served over 300 refugees.

The program operates from January 26, 2018 to January 20, 2019, so all of the grant was not utilized by December 31, 2018.

Islamic Relief

This program provided daily English instruction to students ages 5-18. It also pays for each family's internet. The program is operated by 200m and each teacher works with the students using textbooks provided by the program. We have 68 refugee students who are also provided with notebooks, tablets and other school supplies.

The program operates from November 2018 to August 31, 2019, so all of the grant was not utilized by December 31, 2018.
