All but \$258,340 of this net income amount represents income reported on the Organization's tax return, but not income that was actually received and reflected in the Fund balances as shown on the Organization's books. Thus, an adjustment of \$1,745,045 (\$2,003,385 minus \$258,340) is necessary to reconcile the net assets and Fund balances at the end of the year as shown on the Organization's tax return with the Organization's books.

The Foundation is exempt from federal income taxes as a Section 509(a)(3) not-for-profit organization and files Form 990 annually with the Internal Revenue Service. When any organization's annual returns are filed, some tax positions taken are highly certain to be sustained upon examination by the taxing authorities, while others may be less certain about the technical merits or the amount of the tax benefit that would ultimately be sustained. Management evaluated the Foundation's tax positions and concluded that it had taken no tax positions that required adjustment in its financial statements as of December 31, 2018 and 2017.
