Shipping Medical Supplies and Equipment: Most mission hospitals lack important medical equipment and even basic supplies. Global Health Ministries (GHM) gathers donated medical items, from exam gloves to ultrasounds, and matches them to requests from partners in developing countries. We purchase and ship and source new equipment as well, making quality health care accessible for some of the world's most vulnerable people.

4b (Code:) (Expenses \$ 819,674, including grants of \$ 667,273.) (Revenue \$ 0.)

Community Based Sustainable Development/Capacity Building: Global Health Ministries supports grassroots efforts to improve community health, partnering to train and sustain village health workers who share information about disease prevention and basic first aid and promote the importance of clean water, nutrition and prenatal care and wellness for moms and babies. Research shows 80% of rural health problems in developing countries can be solved by efforts like these. GHM also helps our partners build capacity for improving health through support of construction projects, access to water, equipment purchases (regionally sourced when possible/reasonable) and other strategic projects.

Leadership Training: A shortage of trained health workers in many developing countries jeopardizes lives and compromises people's health especially in rural areas. Global Health Ministries makes training possible for hundreds of nurses, midwives, doctors and other health workers, expanding access to skilled leaders that can save lives. Our consulting services (GHAP) partner with executive healthcare leaders to craft strategies that boost effectiveness.
