1. EARLY EDUCATION PROGRAM: THE EARLY EDUCATION PROGRAM'S OBJECTIVE IS TO PROVIDE CHILDREN AGES 0-6 WITH THE ATTENTION, STIMULATION, AND NUTRITION THEY NEED TO SUCCEED AT THE PRIMARY LEVEL AND BEYOND. THE PROGRAM SUPPORTS CHILDREN'S HOLISTIC DEVELOPMENT AND EARLY LEARNING, HELPING CHILDREN TO MEET KEY MILESTONES IN ACCORDANCE WITH THEIR DEVELOPMENTAL STAGE. THROUGH THE PROGRAM, CHILDREN FROM 0 TO 6 YEARS OF AGE DEVELOP SKILLS IN AREAS OF PERSONAL AND SOCIAL FORMATION IN ORDER TO GRADUALLY BUILD AWARENESS OF THEIR EXISTENCE AS INDEPENDENT PERSONS BELONGING TO A FAMILY, A COMMUNITY, AND TO ONE WORLD. COMMUNICATION IS ALSO DEVELOPED TO EXCHANGE IDEAS, FEELINGS, AND EMOTIONS WITH OTHERS AND TO ENCOURAGE THE DEVELOPMENT OF COGNITIVE PROCESSES THAT FAVOR LEARNING. 2. PRIMARY EDUCATION: PRIMARY EDUCATION IS A FUNDAMENTAL HUMAN RIGHT, CONTRIBUTING TO THE MITIGATION OF CHILD LABOR, AS WELL AS ALLOWING INDIVIDUALS TO PLAY AN ACTIVE ROLE IN SOCIETY.
