| <p>28 The year 2018 was a difficult one for the Valhalla Project volunteer cadre. Injuries and health issues with the management team slowed activities and hampered outreach. Concomitantly, veteran participation declined, apparently due to growing cultural emphasis on social media activities rather than actual participation building traditional skills on a rural homestead environment. As a result, we were able to maintain operations at previous levels but were unable to initiate new programs or expand our activities.
