IFG accounts for income taxes under the asset and liability method in which deferred tax assets and liabilities are recognized for the future tax consequences attributable to differences between the financial statement carrying amounts of existing assets and liabilities and their respective tax bases. The Association and Foundation follow guidance issued by the Financial Accounting Standards Board ("FASB") with respect to accounting for uncertainty in income taxes. A tax position is recognized as a benefit only if it is "more likely than not" that the tax position would be sustained in a tax examination, with a tax examination being presumed to occur. The amount recognized is the largest amount of tax benefit that is greater than 50% likely of being realized on examination. For tax positions not meeting the "more likely than not" test, no tax benefit is recorded. The Association's and Foundation's Form 990 has not been subject to examination by the Internal Revenue Service or the state of Michigan for the last three years. The Association does not expect the total amount of unrecognized tax benefits to significantly change in the next 12 months. The Association recognizes interest and/or penalties related to income tax matters in income tax expense. The Association did not have any amounts accrued for interest and penalties at December 31, 2018 and 2017.

Should a conflict of interest arise and a committee member or consultant fails to declare a conflict of interest, the president shall determine the sanction up to and including removal for cause.
