SHH operates a licensed hospital and long-term care facility and is the successor to both Spectrum Health Kent Community Campus ("SHKCC") and Kent Community Hospital Corporation, which was the original beneficiary of the Foundation. SHKCC and the Foundation entered into a Gift Agreement in 2002, which was restated upon SHH becoming the successor to SHKCC, providing an annual gift to SHH. The amount of the gift is equal to five percent (5%) of the fair market value of the Foundation's assets, based on the prior three (3) years rolling average. Payment of the gift is contingent upon an annual certification from SHH that it continues to participate in the Medicare and Medicaid programs and serves a disproportionately high number of elderly and indigent patients. The use of the gift funds is unrestricted.
