We support people to have a meaningful life by working and contributing to their communities. Our services include Community Based Day Services, Community Employment Services, Pre-Employment Training Services, Residential Community Supported Living, and Children's Services. Community Based Day Services are designed to maximize a person's ability to manage everyday life activities in their community. People become involved in a wide range of opportunities planned by and for them to address individual needs, goals and interests. Through life skills coaching and personal connections, individuals grow to become more active members of their community. These activities include supporting individuals to give back to their communities through volunteering for local non-profit organizations. Service participants spent approximately 18,000 hours in meaningful community integrated activities in 2018.

Headwaters provides flexible, customized Residential Community Supported Living Services for a number of individuals who live in their own apartments in the community, but also need support in those apartments to be successful.
