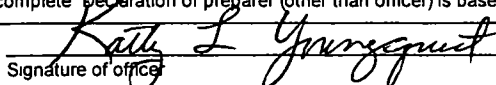

During 2018 Redeemer had 31,696 resident days (73.0% occupancy). Utilization by payor source was as follows: 86.5% Medicaid, 4.7% Medicare, 7.0% Private Pay and 1.8% HMO.
