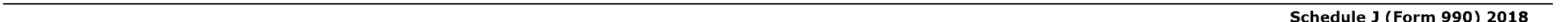

The process was last performed in 2017 for President, Trista Harris. The results of this independent comparison is then reviewed and approved by the President of the Council. This process was last performed in 2017 for officers and key employees of MCF.
