The Community Legal Advocacy Program provides advocacy assistance and support to victims who reside in SW Hennepin County. Participants in this program do not request or require shelter. Advocates provide safety planning, information about court processes and victim rights and assist participants in the preparing of protection orders, therapy, and support groups. Sojourner advocates also work with victims of harassment, stalking and sexual assault. They provide advocate support in criminal, family, and various civil court matters and all services are free and confidential. Community based legal advocacy services provided support to 884 individuals victimized by domestic violence in 2017. Community program activities also include volunteer support activities. The activities of this department are intended to build community awareness and support the work of Sojourners mission.

Form 990, Part III, Line 4c:

The Outreach and Education Department coordinates the educational presentations in schools and community organizations and groups to increase understanding and safety awareness related to domestic abuse and dating. There were over 9,000 audience members that attended presentations in 2018. This department also plans and coordinates trainings for law enforcement, prosecutors, guardians ad litem, probation officers, and other professional personnel. The Volunteer Department promotes active involvement of community members in various roles that support Sojourners programs and services.
