FAMILY MEMBERS WORKED MORE THAN 3,400 SWEAT-EQUITY HOURS TO "EARN" THESE HOME IMPROVEMENTS. COMMON HOPE ALSO IMPROVED AND OPERATED THE INFRASTRUCTURE FOR NEW HOPE VILLAGE INCLUDING RUNNING WATER, ELECTRICITY, AND SEWER, TO HELP FAMILIES WHO HAVE RELOCATED FROM MARGINAL HOUSING IN GUATEMALA CITY.
