The mission of CUFH is to "Provide shelter and support in a spiritual setting" for men and women, as well as families, whether two-parent, single-parent, or same-gender, experiencing homelessness in the FM area. All persons are welcome regardless of faith or spiritual perspective, including those embrace no faith tradition or practice. In the subsequent 31 years since opening, the organization has grown from the basement of the old Bethesda Swedish Church building to multiple facilities, the main shelter at 1901 - 1st Avenue North which shelters approximately 90 people each night. In March of 2018, CUFH completed construction on a 43-unit permanent supportive housing apartment building for men, women and families. Embracing "Housing First" principles, we strive to move residents from the shelter to stable housing as quickly as possible. On December 31, 2018, CUFH merged with the Dorothy Day House of Hospitality and its two food pantries. The organization now boasts two emergency shelters, both offering community services, two food pantries, a permanent supportive housing apartment building with a small food pantry for residents and 10 clients in scattered site HS with a Case Manager Services 1901 Shelter. Sheltered 435 unique individuals including 99 children in 2018. The shelter also provided emergency winter overflow shelter during the coldest month for 145 unique individuals. CUFH also operates a Community Center, open to the public daily, 8:00 am - 7:00 pm. The Community Center offers free hot meals daily, a free Community Bread Shelf, and access to a Shelter Nurse for information and referrals. The Community Center served over 80,785 meals in 2018 and had 9,500 volunteer hours. Permanent Supportive Housing BSA provides 43 units of permanent supportive housing for adults and families. Bright Sky housed 64 adults and 53 children in 2018. Supportive services at BSA include rental assistance, case management and referral, and support and empowerment groups.
