IN 2010 MR. AND MRS. WEIDENWEBER DONATED AN APPROXIMATELY 5 ACRE PARCEL OF PRIME REAL ESTATE IN A PORTLAND SUBURB, KNOWN AS SHERWOOD, WHICH INCLUDED A HOUSE, A GUEST HOUSE AND SOME PERSONAL PROPERTY. THIS IS COLLECTIVELY REFERRED TO AS PARRETT MOUNTAIN AND WAS DONATED TO A CALIFORNIA NON-PROFIT NAMED VENTURES BEYOND (FKA PURPOSE DRIVEN MISSIONS). VENTURES BEYOND WAS A NON-PROFIT THAT HAD BEEN PREVIOUSLY OPERATING FOR MANY YEARS IN CALIFORNIA AND IN CONNECTION WITH FORREST D. REINHARDT'S PRIOR EMPLOYER (SADDLEBACK VALLEY COMMUNITY CHURCH) BUT WAS NOW LIMITED TO SIMPLY HOLDING PARRETT MOUNTAIN. MR. REINHARDT WAS ONE OF THREE BOARD MEMBERS OF VENTURES BEYOND.

IN JULY OF 2015, FORREST D. REINHARDT, ALSO A BOARD MEMBER OF KERITH SPRINGS LODGE (KSL) REQUESTED TO TEMPORARILY TRANSFER PARRETT MOUNTAIN FROM VENTURES BEYOND TO KSL FOR A VARIETY OF STATED REASONS AND KSL AGREED. MR. REINHARDT HAD PREVIOUSLY INDICATED TO KSL THAT HE INTENDED TO TRANSFER PARRETT MOUNTAIN DIRECTLY TO TRILLIUM SPRINGS (ANOTHER NON-PROFIT ON WHICH MR. REINHARDT WAS ONE OF THREE BOARD MEMBERS) OR SOME OTHER NON-PROFIT SINCE VENTURES BEYOND NEEDED TO BE DISSOLVED.

AROUND DECEMBER 21ST OF 2015 MR. REINHARDT ASKED KSL TO URGENTLY COME TO HIS OFFICES TO SIGN A DEED OF TRANSFER MOVING PARRETT MOUNTAIN OUT OF KSL BEFORE THE END OF KSL'S CALENDAR YEAR. KSL PRESUMED AT THIS POINT THAT THIS WAS COMPLETING HIS PREVIOUSLY STATED PLAN TO TRANSFER PARRETT MOUNTAIN TO TRILLIUM SPRINGS OR ANOTHER NON-PROFIT. KSL SIGNED THE DOCUMENTS UNKNOWINGLY EFFECTUATING AN IMPROPER TRANSFER OF PARRETT MOUNTAIN TO FORREST D. AND SUSAN J. REINHARDT, PERSONALLY.

IT WAS SUBSEQUENTLY BROUGHT TO THE ATTENTION OF KSL IN JUNE 2017, BY A

THIRD-PARTY, THAT PARRETT MOUNTAIN HAD BEEN TRANSFERRED TO THE REINHARDTS PERSONALLY AND NOT TO TRILLIUM SPRINGS OR SOME OTHER NON-PROFIT. THIS WAS THE FIRST TIME KSL BECAME AWARE OF THE IMPROPER TRANSFER. ONCE AWARE OF THE IMPROPER TRANSFER, KSL PERFORMED AN INTERNAL REVIEW OF THE TRANSACTION LED BY NEWLY HIRED COUNSEL. KSL'S INTERNAL REVIEW INCLUDED AN UNSUCCESSFUL ATTEMPT TO MEET WITH MR. REINHARDT. THIS INTERNAL REVIEW CULMINATED IN KSL SENDING A LETTER DATED OCTOBER 20, 2017 TO THE REINHARDT'S DEMANDING THAT THEY CORRECTIVELY RETURN PARRETT MOUNTAIN TO KSL.

MEANWHILE THE REINHARDT'S HAD TRANSFERRED THE PARRETT MOUNTAIN PROPERTY ON OCTOBER 10, 2017 TO THE NON-PROFIT TRILLIUM SPRINGS. NEVERTHELESS ON NOVEMBER 13, 2017, MR. REINHARDT HAD TRILLIUM SPRINGS TRANSFER THE PARRETT MOUNTAIN REAL PROPERTY AND MISC. PERSONAL PROPERTY BACK TO KSL IN ACCORDANCE WITH KSL'S DEMAND LETTER OF OCTOBER 20, 2017.

ON OR ABOUT APRIL 16, 2018 THE REINHARDT'S WERE EVICTED FROM THE PARRETT MOUNTAIN PROPERTY WHERE THEY HAD BEEN LIVING SINCE 2010.

THE ABOVE TRANSACTION IS ONE OF THE ALLEGED IMPROPER ACTS COMMITTED BY FORREST D. REINHARDT AS DESCRIBED IN THE ATTACHED COMPLAINT. THE OREGON STATE ATTORNEY GENERAL LAUNCHED AN INVESTIGATION THAT CULMINATED IN AN ENFORCEMENT ACTION THAT IS PENDING IN MARION COUNTY CIRCUIT COURT IN SALEM, OREGON. (SECOND AMENDED COMPLAINT, ATTACHED.)
