PUBLIC POLICY The Company is very active in their Policy Development and Policy Implementation activities. Opinionnaires are sent to all members each year dealing with local, state & national issues. Proposed resolutions are presented at a board meeting in July. Members are invited to this meeting where resolutions are debated & amended. Adopted resolutions are supported by the voting delegate at the state policy conference. A regional board meeting is held to discuss & surface county issues. The Company invites County Supervisors, Treasurer, Engineer, Auditor & Sheriff to meetings to discuss county budget and other subject matters pertaining to the county. Board members regularly attend Legislative Coffees and otehr meetings that involve issues relating to the county. The Company's voting delegate attends meetings and talks with Senators & Representatives. Board members attend FB days at the State Capital to support company policies. The Company has a very active and willing Response Team. State representatives attended local FB meetings to discuss various issues.

AG EDUCATION The Company strongly supports Agricultural Education and has worked very hard at keeping the local schools aware of how important agriculture is. The ways the have accomplished this is by conducting Agriculture In The Classroom (AIRC) activities in 43 area schools. Supported the 2018 Loess Hills AIRC that is just starting in SW Iowa. Supported the local FFA program. Helped sponsor a Soil Judging Contest for FFA members at Wallace Research Farm. The Company participated and donated to the Farm Safety Day held at the Westfair. The Company also awarded 6 college scholarships totaling \$4,100. The Company sent local young farmers to the Young Farmers & Leadership Conference. Sponsors a Heifer Program where 2 8th grade students were chosen to participate and received 3 heifers. The students will care for these heifers for 5 years and hopefully have 15 calves at that time. The students report to Board about feed costs and expenses. At end of 5 years the student repays the county the cost of the heifers or replaces the heifers for the next student chosen for program.

PUBLIC RELATIONS The Company is very strong and active in this area. Several health screenings have been hosted such as Stroke Detection Plus events at the county office. The Company also sponsored VNA to come to the annual meeting where health information was provided to members as well as conducting blood pressure screenings. The Company supports numerous events at the County's Westfair. The Company sponsors the Pancake Man who makes pancakes for the 4-H's fair breakfast. The Company also gives a scholarship to the Outstanding 4-H'r along with \$2 to each apple pie maker. Board members handed out commemorative volleyballs, basketballs, footballs & baseballs to area schools that advanced to state playoffs. Each of the presenters talked to students about how Farm Bureau supports the kids not only with the balls but with scholarships for education. The Company helped fund a baby seat promotion. Helped various organizations at Christmas time with monetary donations. Care & Share, Caring Ministries, Hope Net Ministries, New Vision Homeless Services.
