From the results of the opinionnaire, a committee developed the proposed resolutions which were presented at the Company's annual meeting in July. Those attending discussed and adopted policies which were sent to the Iowa Farm Bureau Federation to be included in state results. A board member attended the Washington DC legislative trip to lobby for agriculture. The board president attended the Presidents Conference. A board member attended a group visit to Senator Grassley's office where the group raised several questions on concerns facing farmers today.

EDUCATION/AG IN THE CLASSROOM The Company employs and sponsors an Ag In The Classroom coordinator who reached approximately 6,000 local area students during the school year to teach them about agriculture. A scholarship committee was formed that developed guidelines, accepted & reviewed applications and awarded 8 student scholarships. In May the Company co-sponsored a 4th Grade Safety Day Camp for Bremer County students. Approximately 350 students attended this event. The Company sponsored the volunteer lunch for the 4th Grade Safety Day Camp. The Company provided member's children with \$10 each towards their kids 4-H dues.

PUBLIC RELATIONS The Company participated in and sponsored a number of events for the benefit of members and non members alike. In March the Company co-sponsored with local banks a Farm Bill/Crop Insurance meeting. Several board members attended and the Company helped sponsor the food for the event. The Company hosted a Stroke Detection Plus health screening 4 times during the year. A Health Day with a local hospital was also sponsored which provided members and the general public a low cost 23 profile blood draw. The Company sponsored a Corn-Feed and watermelon feed during the Bremer County Fair. The Company sponsored a Centennial Picnic in June where the meat & cake were provided.
