If there is a potential conflict of interest, the interested person may make a presentation at the board or committee meeting, but after such presentation, she or he shall leave the meeting during the discussion of, and the vote on, the transaction or arrangement that may result in a conflict of interest. The President of the board is responsible for monitoring compliance.
