The Executive Director's compensation represents the portion of time spent on Foundation-related activities.

This compensation is funded by donor dollars, and duties include overseeing and administering the Foundation's balance sheet, fundraising and distribution of grants, engaging with the local community on mission-related activities and advocating on behalf of Iowans for issues related to financial health and well-being.

Outside of the work performed by the Executive Director on Foundation-related activities, the Executive Director is also provided compensation from a contract agreement with Affiliates Management Company (AMC). The Foundation and AMC share a common paymaster, and due to this, the compensation outlined above does not match the Executive Director's 2018 W-2 reported income, which also included earnings from the AMC contract. AMC-earned income is not funded by donor dollars.
