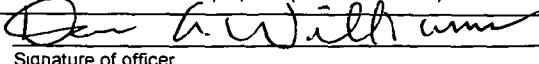

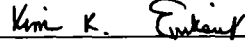

The Metro Chaplaincy Program was established in 2002 and has a contract with the Mobile County Sheriff's Office. The program's complex in Metro Jail includes a chapel and classroom for inmates. The Organization's Chaplain and staff administrator are responsible for coordinating pastoral, religious and educational services. Support is provided by 39 congregations and 150 volunteers. Pre-release services include GED classes by Goodwill Easterseals, Celebrate Recovery and Fatherhood Initiative.

Neighbor Center is a community-based reentry services for returning neighbors. This program is available to former inmates from local, state and federal facilities. Case managers and volunteers provide services and support. Assistance helps secure housing, employment, education, job training, transportation, health care, transportation, treatment for mental health and addictions, legal services and address other needs and barriers. Individual service goals are focused on financial stability that supports self-sufficiency thereby preventing reincarceration.

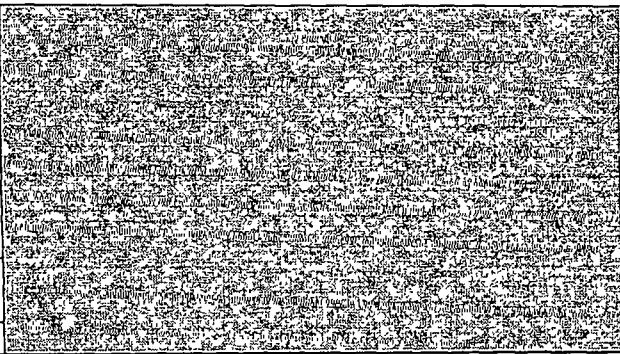
