Our 2018 Form 990-EZ is being filed late and without extension. We respectfully request that any tax filing penalties be waived by the IRS since we believe that there was reasonable cause for the late filing.

We are a charitable fund-raising organization run by volunteers and there are no full-time employees. It is the responsibility of each council's Financial Secretary to file a Form 990-EZ by the fifteenth day of the fifth month following the end of the council's annual accounting period.

Dennis Smith, the Financial Secretary from July 1, 2015 to June 30, 2018, submitted his resignation March 26, 2018, and resigned due to medical reasons and the length of his term in office. Mark O'Donnell replaced Mr. Smith as Financial Secretary effective July 1, 2018. Mr. O'Donnell and Mr. Smith met a few times to discuss the duties and responsibilities of the position, but the transition was not a smooth one given that Mr. Smith was undergoing radiation therapy for melanoma of the face.

Mr. O'Donnell submitted his resignation on February 6, 2019 to be effective upon the nomination and approval of a new Financial Secretary. Mr. O'Donnell stated in his resignation letter that he did not realize the time commitment required and that he could not adequately serve as Financial Secretary due to the time demands of his job.

Ron Krentz was approved as the current Financial Secretary, effective April 1, 2019. Due to Mr. O'Donnell's busy work schedule, there was no transition plan for Mr. Krentz, the successor, to follow.

Upon receiving a notice dated September 30, 2019 and conducting further investigation, we realized that a Form 990-EZ was required and took immediate steps to file the return.

To avoid this problem in the future, we have added the May 15th annual due date to our event calendar.

Being a volunteer organization and unfamiliar with these tax filing requirements, there was no willful neglect.

In summary, once the overlooked tax filing was discovered, we took immediate steps to rectify the problem and establish a procedure to make certain this oversight does not reoccur in the future. Accordingly, we respectfully request that any 2018 tax filing penalties be abated.
