The undersigned certify that:

1. They are the president and the secretary, respectively, of The BentProp Project Limited, a California nonprofit corporation.
2. The Articles of Incorporation of this nonprofit corporation are amended and restated as follows:

**ARTICLE I
NAME OF CORPORATION**

The name of this corporation is Project Recover, Inc.

**ARTICLE II
PURPOSE OF CORPORATION**

2.1 This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Corporation Law for charitable purposes.

2.2 The specific and primary purposes of this corporation are:

(a) Educating the public concerning United States ("U.S.") military personnel missing in action in the battles of World War II, the Korean War, Vietnam, and other U.S. military missions;

(b) Educating the public concerning the efforts of individuals and organizations involved in research to locate U.S. military personnel missing in action;

(c) Educating the public concerning the efforts of individuals and organizations involved in search and recovery of U.S. military personnel missing in action; and

(d) Carry on other charitable activities associated with this goal as allowed by law.

2.3 The general purposes and powers of this Corporation are to exercise all the powers of a nonprofit public benefit corporation under the laws of California, including the power to contract, rent, buy or sell personal or real property; provided, however, that this Corporation shall not, (i) except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the primary purposes of this Corporation, or (ii) carry

on any activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code.

**ARTICLE III
TAX-EXEMPT STATUS OF CORPORATION**

3.1 This corporation is organized and operated exclusively for the purposes set forth in Article II hereof within the meaning of Internal Revenue Code section 501(c)(3).

3.2 No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate or intervene in (including publishing or distributing statements) any political campaign on behalf of (or in opposition to) any candidate for public office.

3.3 All corporate property is irrevocably dedicated to the purposes set forth in Article II. No part of the net earnings of this corporation shall inure to the benefit of any of its directors, trustees, officers, private shareholders or members, or to individuals.

3.4 Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed to a nonprofit fund, foundation or corporation which is organized and operate exclusively for charitable, educational and/or religious purposes and which has established its tax-exempt status under Internal Revenue Code section 501(c)(3).

3. The foregoing amendment and restatement of Articles of Incorporation has been duly approved by the board of directors.

4. The corporation has no members.
