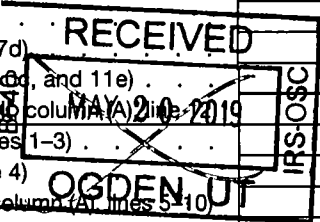

Athens PRIDE Festival. The Athens PRIDE festival event was held on a Sunday after a week long set of PRIDE events each evening. The festival included more than 25 vendors and had booths for non-profits and informational booths as well. The festival ran from 2:00 pm until 9:00pm. Festival goers could dine at several food trucks and Athens establishments on the street. A main stage was used for a DJ, a Divas under the lights show, and a performance by RuPaul Drag Race contestant, Latrice Royal. The event used a blocked off area between two main streets in town and drew festival goers from Athens and the surrounding counties.

Athens PRIDE Queer Prom: The Queer prom, hosted at the Venue "Little Kings" was a themed event that provided an opportunity for LGBTQIA community members and allies to attend a prom with anyone with whom they chose. The prom served as a safe space for a formal event for community members, especially to serve those who may not have had the opportunity to attend their prom or attend their prom with whom they chose because of how they identified and the possibility for them not to be safe. A professional DJ played music and there were several local drag queens who hosted and crowned the prom royalty.

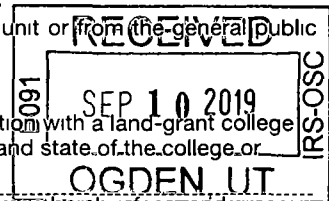
