<p><b>28</b></p> <p>The 1947 Partition Archive recorded and preserved oral history interviews from 2402 Partition witnesses in 2017, of which 1634 were archived by 18 trained volunteer student archivists who in total donated 5760 hours of service to the cause. The organization directly served 2402 elderly Partition witnesses over age 75, by recording their oral histories and approximately 4800 individuals who are children of witnesses and over 47200 grandchildren of witnesses. The 1947 Partition Archive trained 362 members of the general public via its' free oral history workshop, of whom 151 went on to record and submit oral histories of Partition witnesses from their communities, and became confirmed Citizen Historians and trained oral historians.
