We work with youth organizations on plastic pollution and have started work on the issue of deep sea mining.

Regulation of high seas - the discussions and decisions continue their process through the UN and we remain actively involved. The more recent discussions of BBNJ have not included the issue of seabed mining, but we are in conversations with numerous NGOs regarding the inclusion of protections against deep sea mining.

Marine Protected Areas - The efforts in MPAs continue as we work with numerous countries. MPAs are critical as areas of refuge and regeneration. We are seeing increased challenges to the establishment of MPAs, including a threat to the waters around Australia, in the Great Barrier Reef and the Great Australian Bight, where a foreign oil company has submitted an application for drilling rights. We continue to work to prevent additional threats to these waters.
