

Organization's primary exempt purpose: to empower and support individuals with Down syndrome, their families and the community through education, information, public awareness and advocacy. DSNMC supports 400+ families in Montgomery County and the metro area. DSNMC has been consistently successful in achieving its mission, with many initiatives undertaken throughout the year.

LINE 28: STEP UP WALK - DOWN SYNDROME AWARENESS WALK - DSNMC holds an annual awareness walk in October during Down

Syndrome Awareness Month to raise awareness in the community about DS and about what challenges people with DS face and what their capabilities are. More than 500 people attend the walk. Individuals and corporations donate to this fundraising event. Money raised is used for the general administration and for various projects that carry out the organization's mission. Expenses incurred are for equipment and facility rentals, food, T-shirts, DJ, promotional and advertising materials.

LINE 29: TECHNIQUES FOR SUCCESS - This covers education strategies for students who have Down syndrome and other intellectual

disabilities, attending pre-school to high school. It is for both parents and educators including administrators, therapists and counselors to learn best practices. There were approximately 400 attendees. The format allows for breakout sessions so people can listen to the topics most applicable to their child's/students' needs. This conference has received accolades from parents, Montgomery and Frederick County Public Schools and the Archdiocese of Washington DC schools.

LINE 30 YOUNG ADULTS/SELF-ADVOCATES POSITIVELY SPEAKING WORKSHOPS - This is an award winning program in conjunction with

ArtStream, a series of public speaking and social interaction workshops where the self-advocates work with peer mentors to learn how to handle social situations and become more confident speakers. Simultaneously, parents and caregivers/guardians share their experiences and listen to speakers invited to talk about employment support, finances, independent living, health concerns, use of technology, etc.

OTHER PROGRAMS that carry out the mission of DSNMC: DSNMC hosts social events for children with DS of all ages, their parents and

families. These are the Winter Dance, Spring picnic, Summer pool party, playdates, new Family breakfasts, and Tools for School parent

workshops. DSNMC has an active listserve so parents can connect, ask questions and share resources. DSNMC has a Latino group which

meets bi-monthly in addition to attending regular events. We reach out to families who receive a pre-natal or post-natal diagnosis of

Down Syndrome. We present new families with a welcome kit and link them with other families. DSNMC fosters advocacy by having members

attend the Buddy Walk on Washington at Capitol Hill each year to meet with elected officials and discuss topics of concern to the community.
