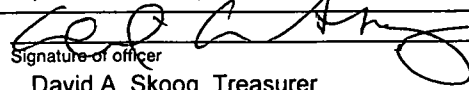

Eight of the causes were specific assistance to individuals: seven distributions to assist medical patients with their medical or other expenses and one distribution to assist a family with funeral expenses after an unexpected death.
